Protection against Violence in the Family



Protection against Violence in the Family

Domestic violence is injurious, criminal and no private matter.



Have you been a victim or been threatened?

In the case of acute threat dial the emergency number 110! The police will do whatever is necessary to protect you. It is possible that the offender can immediately be removed from the residence.

Report the crime to the police. You can file a criminal complaint directly on site or at any police station.

Expulsion from the Residence

If violence is subjected, the police can expel the abuser from the residence and issue a restraintment order for multiple days if there is a danger of reoccurring violence.

Restraintment and Proximity Prohibition

Depending on the situation, the police can issue an extended Restraintment and Proximity Prohibition for multiple days. If necessary, this can also be applied to extended living environment for example, the work place.

If the abuser does not fully comply to the restraintment order, **please notify the police immediately!**

The Violence Protection Act

Supplementary protection and readjustment from acts of violence is provided by The Violence Protection Act.

The Family Judicial Court enacts temporary provisional application orders:

- Restraintment order from entering the residence (usually 6 months)
- Proximity Restraintment order for keeping within a specified distance from the residence and work place as well as other abodes of the children etc.
- Contact Prohibition (personally, by Messenger or email etc.)

In order to assert the corresponding prohibitions, applications are made through a lawyer or via The Citizens Advice Bureau at the District Court.

In the case of difficulty, it is possible to apply for legal costs aid.



Consultation



Before, after or at the time of the Restraintment Order, consider clarifying your own living situation and developing new perspectives.

Specifically meaning:

Consultations Offices against violence are a contact point for all kinds of standing queries or issues.

Women's and children's shelters help and support affected women and children, e.g. by:

- Analysing legal enquiries
- Reviewing financial problems
- Crisis Management

No matter what type of abused woman, the admission in a Women's Home is possible.

Where children are concerned

When there are children in the household, The Youth Welfare Office will become involved

- With Restraintment Orders; or if necessary,
- To take up legal proceedings in the Family Court in accordance to The Violence Protection Act.

It is the Youth Welfare Office's duty to advise and support the family concerned with practical aid. Thus, the protection of the children is at the forefront.

The Youth Welfare Office also offers advice on Separation/Divorce, Parental Care and General Rights, hence providing mediation in the department concerned.

The consultation is always confidential.
